As above	As above	<p><b><u>Nets (not applicable)</u></b></p> <p>Follow ECB guidance on use of nets, including:</p> <ul style="list-style-type: none"> <li>• A controlled booking system to manage use</li> <li>• Maintain social distancing</li> <li>• Clear signage with guidance and rules of use</li> <li>• Cleaning station accessible for users</li> <li>• Avoid equipment sharing where possible</li> </ul>	<ul style="list-style-type: none"> <li>• Clear communication to members including detailed guidance</li> <li>• Encourage players to bring their own sanitiser</li> <li>• A club representative on site</li> <li>• Consider player circulation in enclosed nets</li> <li>• Temporary cone placement to illustrate socially distanced queuing positions for bowlers and separation between nets</li> </ul>			

As above	As above	<p><b><u>Group Coaching Sessions &amp; Small sided games</u></b></p> <ul style="list-style-type: none"> <li>• Maximum of 20 people in the sports hall including players, coaches etc. Ensure two adults are present at all practices/training involving under-18s</li> <li>• Only one-to-one coaching and small group (one-to-five) coaching is permitted</li> <li>• A controlled booking system to manage use</li> <li>• Coach to ensure all surfaces are clean and any equipment is cleaned before and after use with antibacterial spray</li> <li>• Maintain social distancing</li> <li>• Avoid equipment sharing where possible</li> </ul>	<ul style="list-style-type: none"> <li>• Coach to explain the safety guidelines of what is expected pre, during and post session</li> <li>• No spectators are permitted in or outside the hall.</li> <li>• Viewing gallery will be closed.</li> <li>• Access to changing rooms for toilets only.</li> <li>• Showers not permitted.</li> <li>• Coaches, team managers, must wear face masks.</li> <li>• Practice in small groups or 'bubbles' when training whenever possible, with groups working together throughout the session to reduce risk of transmission.</li> <li>• Social distancing rules apply if not on the court in a playing capacity. Players must be socially distanced on benches/chairs.</li> <li>• To lower the frequency of bodily contact, players/teams must have no handshakes, celebrations/high fives.</li> <li>• Shouting is not permitted in the sports hall due to the increased risk of aerosol transmission.</li> <li>• No congregating once training,</li> </ul>	AJ	01/09/20
